SHRI K. MOHANAN: My question is keeping apart the religious and environmental considerations, whether the Government will, in the interest of the future of this country, clear at least some major projects... Is the time over, Sir?

MR CHAIRMAN: It will be over, if you go on askng like this. I am only helping you.

SHRI K. MOHANAN; Anyway, I will not get the 'answer since the time is over.

MR. CHAIRMAN: Not yet. .

Consideration of such clearance from forest angle can be taken up only when the complete details sought from the State Government are received. It is not possible to indicate whether or when the project will be cleared
