(c) if so, what is Government's reaction thereto?

THE MINISTER OF STATE IN THE DEPARTMENT OF REVENUE IN THE MINISTRY OF FINANCE (SHRI AJIT PANJA): (a) M/s. William Industries are manufacturing Nylon socks which are chargeable to nil rate of duty under Central Excise Tariff. Thus there is no question of evasion of central excise duty by them.

(b) and (c) M|s. William Industries had preferred two refund claims for Rs. 40,07.370.86 paid by them as central excise duty during the period March, 1975 to September, 1980. Both the claims were rejected by Assistant Collector against which the said company preferred revision application directly to Central Government. The same were finally dismissed by Customs, Excise and Gold Control Appellate Tribunal-1 on the ground of direct submission of the petitions to the central government against Assistant Collector's orders.
