1706. SHRIMATI BIJOYA CHAKRA-VARTY: Will the Minister of LAW AND JUSTICE be pleased to state:

- (a) whether all the vacancies of Judges in the Guwahati High Court have since been filled up and *if* so, what are the details in this regard;
