## CENTRAL ASSISTANCE TO ORISSA TO MEET THE DROUGHT SITUA-TION

SHRI **BASUDEB MOHAPATRA** (Orissa): Sir, serious drought condition is prevailing in the State of Orissa. All the 13 districts have been affected by drought except some irrigated patches. The total cultivable area under irrigation is only 26 per cent. The rest of 74 per cent of and depends on rainfall for good harvest.

The State Government has sought an assistance of Rs. 155 crores from Centre. The Central team has visited the drought affected area and assessed situation. But the gravity of the situation can be well imagined from a press report appearing in the "AMRIT BAZAR PATRIKA", date the 26th of August, 1987. Sir, the report says:

"Mr. M. D. Asthana, leader of the Central team currently visiting drought-hit areas of Orissa, today assured that the Centre would provide the required financial and foodgrains assistance to the State to meet situation arising out of the calamity.....

"Dr. Asthana, who made an on-thespot assessment of the drought situation in the western Orissa districts of Kalahandi and Bolangir during past two days described the situation there as "very unhappy".

Sir, in view of this, besides demanding Rs. 155 crores in its memorandum, the State Government has requested the Central Government to supply 70,000 tons of rice per month against a supply of 20,600

ton per month at present in order to strengthen the public distribution system in drought affected areas.

Mensions

Since the Centre has already sanctioned Rs. 250 crores for other droughthit States, Orissa should get its due share immediately.

The Central Government should make arrangements to provide edible oil and other essential commodities to Orissa in adequate quantity.

Drinking water is a problem in Orissa, specially in backward and tribal and also in saline belt. Sufficient amount should be allocated for this purpose.

Liberal Central assistance should be given to Orissa to meet the situation immediately.
