THE MINISTER OF STATE IN THE DEPARTMENT OF POWER IN THE MINISTRY OF ENERGY (SHRIMATI SUSHILA ROHATGI): (a) and (b) No Project by the name of Lokdeep could be identified in the Ministry of Energy.

Shortage of power in West Bengal

- 872. SHRI SUNIL BASU RAY: Will the Minister of ENERGY be pleased to state:

THE MINISTER OF STATE IN THE DEPARTMENT OF POWER IN THE MINISTRY OF . ENERGY (SHRIMATI SUSHILA ROHATGI): (a) The findings of the West Bengal Power Perspective Planning Committee are not available with the Department of Power.

- (b) The States is expected to, by and large, meet its energy requirements by the end of the Eighth Plan_ although, according to the Twelfth Power Survey, there may be a peaking shortage of about 7 per cent.
- (c) An additional capacity of 1095 MW is expected to be commissioned in the State Sector during the Eigth plan period. Besides, the State would get its share of Power from the Central projects.

Renovation" of DPL Units
