Under the Modified Plan of Operation for control of. Malaria which-; is -being implemented since April 1977 the following specific measures are being taken to con tain Malaria;

- 1. To contain the transmission of Malaria.' residual insuticidal spray is being carried out in areas where Annual Parasite Incidence (API) is 2 and above.
- .2. Stress has been laid fop regular fortnightly surveillance in all malarious areas of the country
- 3. Laboratory service has been decentralised at the Primary Health Cen-. tre for prompt examination of blood smaears and administration or radical treatment.

- 4. Drug Distribution Centres and Fever Treatment Depots are functioning 4 in the remote areas of the country to make available anti-malaria drug to the fever cases.
 - 5. To contain P. falciparum strain, a P. falciparum strain Containment Programme is functioning in the problem areas of the country.
