- THE MINISTER OF STATE IN THE DEPARTMENT OF RURAL DEVELOPMENT IN THE MINISTRY OF AGRICULTURE (SHRI RAMA-NAND YADAV): (a) and (b) Yes, Roads in tribal areas on selective basis which are deemed nesessary but could not be covered earlier in the State or Central Plans are to be taken up under a Centrally Sponsored Scheme with 100 per cent grant-in-aid to the States for development roads in tribal areas. - (a) Progress on one of the roads '.c Keonchi Achanakmar road as at the end of March, 87 was as follows:—
  - 1. Earth work on widening of 5.90 kms. of road had been completed.
  - 2 Metalling on 9.40 kms of wideing and 19.30 kms of strengthening of road was completed.
  - 3. Asphalt surfacing of 7.80 kms. was completed.
  - 4. 42 CD works and 6 culverts work. Latest progress of other works is not available in the Ministry.
