- (b) The doctors called off the strike on 29-7-1987 with a view to resume duty.
- (c) It has been decided that there shall be no victimization of the doctors who went on strike
- (d) No such cases have been reported.

### Action against the quacks performing Medical Termination of Pregnancy in Delhi

- (a) whether Government are aware that in Delhi unqualified personnel are undertaking to do medical termination of pregnancies resulting in grave damages to the pregnant women;
- (b) whether any check/survey has been made by the Government so far to detect such unqualified personnel;
- (c) if so, the number of personnel detected as on 30th June, 1987 and action taken or proposed to be taken against each of them; and

(d) what remedial steps have been taken by the Government in this regard?

- (b) and (c) No special survey has been conducted to estimate of the incidence of illegal abortions. In view of the secrecy surrounding such cases and due to their surreptitious nature, it is obvious that no survey can yield any reliable estimates.
- (d) Steps have been taken by way of increasing the facilities and availability of trained man-power to attend to abortion services under the purview of the Medical Termination of Pregnancy Act, 1971 as a health measure.

## Modernisation of Delhi/Bombay Airports

- (a) whether any programme has been taken up by Government for the modernisation, renovation and repair of Delhi and Bombay airports; and
- (b) if so, what are the details thereof?

THE MINISTER OF STATE OF THE MINISTRY OF CIVIL AVIA-TION AND THE MINISTER OF STATE OF THE MINISTRY TOURISM (SHRI JAGDISH TYTLER: (a) and (b) Yes, Sir. With a view to improving Air Traffic Control Services, the National Authority has formulated a proposal for modernisation of Air Traffic Control Systems at Delhi and Bombay airports. At both places, the proposal involves construction of technical blocks and procurement and installation of equipment listed below:-

- (i) Modern long range and Airport Surveillance Radars co-located with Secondary Su veillance Radars;
- Surface Detection (ii) Airport Equipment (ASDE);
- (iii) Terminal Very High Fre-(VOR) coquency-Omni Range located with Distance Measuring Equipment (DME);
- (iv) Category—II Instrument Landing System (ILS) with associated Visual Guidance Systems; and
- (v) Radio Data Processing, Flight Data Processing and Voice Control Communication Systems.

Additionally, taxi-vays and high speed exits are also proposed to be constructed at Bombay Airport

At Delhi Airport Doppler Very High Frequency-Onni Range and Category-III Instrument Landing System with associated Visual Guidance System are a so proposed to be installed.

In addition to above, the following facilities have been provided/are planned: -

#### Delhi Airport

- (i) A new International Terminal Complex has recently been commissioned:
- (ii) The old International Departure Block has been converted into Airbus Departure Block. Other areas of the airport have also been repaired and renovated; and
- (iii) Provision has been made in the Seventh Plan for taking up construction of another international module and the domestic module.

# Bonsbay Airport

(i) Feasibility report for construction of Module-III of International Terminal has been prepared; and

(ii) Modernisation of Domestic Complex is Terminal being planned.
