PANT): (a) to (c) Government addressed M s Bofars on 16th June, 1987, and the Swedish Government on 17th June, 1987, calling for complete details of the individuals companies whom commissions or other payments have been made in respect of the 155 MM Howitzer dea. Bofors' reply, received on 3rd July, 1987, did not provide the specific information asked for by Government. In their reply, Bofors again denied the payment of bribes or the use of middlemen to win their Indian contract. Bofors were again asked, on 16th July 1987, to furnish the specific information asked for in Government's letter of 16th June, 1987. M|s. Bofors reply was received on 10th 1987 and is under examina-August, tion.
