

### Grants and Loan to Orissa .

2089. SHRI BASUDEB MOHAPATRA- Will the Minister of FINANCE be pleased to state:

(a) the amount of grants given to Orissa by the Central Government in the years 1985-86 and 1986-87; and

(b) the amount given to Orissa on loan during the same period?

### Transfer of Soviet know-how in India

(a) whether there is any proposal under Government's consideration for transfer of Soviet know-how in India and establishment of facilities for production; and

(b) whether any specific schemes have been identified for this purpose- if so, the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF SCIENCE AND TECHNOLOGY AND THE MINISTER OF STATE IN THE DEPARTMENTS OF OCEAN DEVELOPMENT, ATOMIC ENERGY, ELECTRONICS AND SPACE (SHRI K. R. NARAYANAN): (a) Yes Sir. Such proposals are included in the integrated long-term Programme of Cooperation in Science and Technology between India & USSR recently signed in Moscow.

(b) The identified areas include Biotechnology and Immunology, Material

Science & Technology and Technology, Catalysis, Space Science & Technology, synchrotron Radiation Source, Water Purification, Computers and Electronics. Details of the individual schemes will be worked out through mutual consultations.

### Separate Cell to unearth black money

(b) if so, the details thereof;
