- (c) and (d) Bharat Petroleum Corporation Limited's distributor Raman Gas Service is catering to Vasant Vihar Area in Delhi and one complaint dated 30.7 1987 pertaining to this distributor was received on August 10, 1987;
- (e) Complaints elating to deliverymen and delays in supply of refills are duly investigated and warnings are issued to the dealers in cases of proven malpractices. This distributorship is also being closely monitored to ensure satisfactory customer service.
