Cut in US aid to India

2731. SHRI KAPIL VERMA: SHRI RAM CHANDRA VIKAL: SHRI CHANDRESH P,, THAKUR:

Will the Minister of EXTERNAL AFFAIRS be pleased to state.

- (a)' whether U.S. House Foreign Affairs Committee has considerably reduced development aid to India under the Foreign Aid Authorisation Bill approved by it; and
- (b) if so, what axe the reasons advanced by the US Committee for the decision and what is OUT Government's reaction thereto?

THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI K. NATWAR SINGH): (a) Yes, Sir. This Aid Bill is yet to be considered by the full Touse of Representatives.

(b) The House Foreign Affairs Committee has advanced no reasons for the proposed aid cut. Government strongly regret the Committee's decision which, as Government sees? it, has resulted from a misconception of India's foreign policy.

Export of textiles to U.S.S.R.

2732. SHRI SATYA PRAKASH MA-LAVIYA: Will the Minister of TEX-

TILES be pleased to state:

- (a) whether it is a fact that a high-level team of the National Textile Corporation is to visit the USSR to discuss ways and means to rugment export of textiles to that country; and
 - (b) if so, what are the details thereof?

THE DEPUTY MINISTER IN THE MINISTRY OF TEXTILES (SHRI S. KRISHNA KUMAR): (a) and (b) The memorandum of understanding signed as a result of the visit to USSR in June, 1987 of a high level NTC de legation led by its Chairman-cum-Managing Director provides, *inter alia*, that NTC delegation will visit Moscow at the end of September, 1987 to negotiate for signing the deal relating to new varieties.

Criminals joining hands with terrorists

2733. SHRI RAJNI RANJAN SAHU: Will the Minister of HOME AFFAIRS be pleased to state:

- (a) whether Government are aware that criminals have joined hands with terrorists in Delhi and Punjab; and
- (b) if so, what are the details of the measures taken to check this menace?

THE MINISTER OF STATE IN THE MINISTRY OF PERSONNEL,, PUBLIC GRIEVANCES, AND PENSIONS AND THE MINISTER OF STATE IN THE MINISTRY OF HOME AFAIRS (SHRI P. CHIDAMBARAM): (a) The interrogation of some of the arrested terrorists in Punjab has reveMed their j links with criminals. In Delhi also investigation reveals that some of the terrorists operating in the capital have criminal back-grounds.

(b) Steps taken include raiding the hideouts of terrorists, their harbour-ers and associates, arrest/detention of I persons suspected of indulging jn terrorist activities, etc.
