doctors have been victimized on account of this strike: by "victimization" I mean wage cut, withholding of increments, removal or dismissal.

Written Answers

KUMARI SAROJ KHAPARDE: I would like to tell the honourable Member that, according to me, not a single doctor has been vicitimized.

DR. G. VIJAYA MOHAN REDDY: Madam, the Government takes the services of doctors. After all, a doctor is a very important person and what is this practice of terminating after 90 days' service? Can you get some kind of specialized services of doctors if you break their service for one day after 90 days' of service? What is this system? Can't you recruit doctors on a regular basis?

KUMARI SAROJ KHAPARDE: Madani. I would like to tell the honourable Member that as and when we have got vacanciesonly on that basis—we can recruit doctors.
