THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (KUMARI SAROJ KHAPARDE): (a) Approximately 2 per cent prevalence of Diabetics is reported in India. The total number of diabetics is about 15 million.

- (b) According to the available in formation, no attempt is being made in India to manufacture synthetic in sulin.
- (c) According to the information available to the Government of India an amount of Rs. 58.91,107 has been spent for import of insulins from Ja nuary, 1986 to November, 1986. The amount of insulin required for each patient varies with the intensity of disease and the duration of treatment. Therefore, it is not possible to say how many patients can be treated with the insulin imported.
