- (a) whether it is a fact that the policy of Government in connection with the filling up of the posts in requisite percentage by the candidates of Scheduled Tribes is also applicable to the Delhi University;
- (b) if so, what are the reasons for which the Delhi University has not filled up even 7-1/2 per cent of the vacancies reserved for Scheduled Tribes during the last forty years; and
- (c) if so, what action Government have taken or propose to take so that the said policy is complied with?

THE MINISTER OF STATE IN THE DEPARTMENTS OF EDUCATION AND CULTURE IN THE MINISTRY OF HUMAN RESOURCE DEVELOP-(SHRIMATI / KRISHNA SAHI) (a) to (c) According to the information furnished by the University of Delhi, the University has adopted the Government policy for reservation for SC & ST for appointments to the non-teaching posts. For teaching posts, the UGC guidelines provide for reservation in appointments upto the level of lecturers/assistant professors only. According to the criteria adopted by the University, all candidates belonging to SC & ST who fulfil the minimum qualifications prescribed the post of lecturer should be invited for interview and preference should be given to such candidates other things being equal. The main reason given by the University for not filling the vacancies reserved upto the prescribed percentage of 7 1 2 per cent for ST is non-availability of suitable ST candidates possessing the prescribed educational qualifications experience.

The University Grants Commission and Government have been impressing upon the University from time to time to ensure that the Government/UGC guidelines for reservation for SC & ST are observed strictly.

Review for the double timing system in C.G.H.S.

- (a) whether there is a proposal under Government's consideration to review the single timing system in the C.G.H.S: dispensaries in Delhi consequent upon the large number of representation from Central Government Employees Welfare Associations;
- (b) whether it is also a fact that there are still double timings system (i.e. morning and evening) in some of dispensaries in Delhi; if so, what are the names of such dispensaries;

- (c) whether Government are aware that single timing system in C.G.H.S. dispensaries causing great hardship to a large number of Central Government employees;
- (d) what are the reasons for this type of discrimination among the beneficiaries of the different locality in Delhi; and
- (e) by when Government propose to start double timings system in all the dispensaries in Delhi?

THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FA-MILY WELFARE (KUMARI SAROJ KHAPARDE) (a) Yes, Sir.

- (c) Some complaints have been received.
- (d) Prior to the changing to the single shift system the dispensaries mentioned in answer to (b) above, were functioning for 12 hours in two continuous shifts of 6 hours each on trial basis. As these dispensaries were already functioning in two continuous shifts of 6 hours each it was decided not to disturb the working of these dispensaries.
 - (e) The matter is under review.
