U.S. Grant for Development of Agriculture

- "363. SHRI DHARAM CHANDER PRASHANT: Will the Minister of AGRICULTURE be pleased to state:
- (a) whether it is a fact that the U.S. Department of Agriculture has recently given grants to the extent of Rs. 63 lakhs to Indian Scientists who work with American counterpart from U.S.D.A. and U.S. Agricultural Universities and the Centre for International Maize and Wheat Improvement;
- (b) if so, what are the reasons that the Ministry are not taking tse assistance from the U. S. Department of Agriculture to develop Agriculture and Horticulture in Punjab to help the farmers of Punjab rather than depending upon a Soft drink company (Pepsi Cola) to develop our agriculture; and
- (c) how many Research establishments are there in Punjab to develop agriculture and horticulture?

THE MINISTER OF AGRICULTURE (SHRI G. S. DHILLON): (a) Yes, Sir. However, the grant agreements are strictly bilateral bet ween the Indian Institutions and the U.S. Department of Agriculture (USDA) and do not include any funds for the Centre for Internaltinal "Maize and Wheat Improvement.

(b) The imputation that the Mm-istrv is "depending upon a Soft Drink Company (Pepsi Cola) to deveop our agriculture" is not correct and is at variance with the factual position. The Ministry is taking assistance from the US Department of Agriculture (USDA) develop Agriculture and Horticulture in Punjab, as is evident from the fact that seven out of a total of 75 Research Projects in India funded by the USDA are in operation in Punjab.

(c) There are 21 Regional Research Stations/Centres/Institutes in Operation in the Punjab State to develop agriculture and horticulture.
