

(a) how much amount have been allocated for development of 'Shakti Sthal' so far;

(b) how much out of it has so far been spent;

(c) how much work has since been completed; and

(d) by when the whole work is expected to be completed?

THE MINISTER OF STATE IN THE MINISTRY OF URBAN DEVELOPMENT (SHRI DALBIR SINGH):

(a) and (b) An allocation of about Rs. 233 lakhs has so far been made for the development of Shakti Sthal complex, out of which an expenditure of Rs. 175 lakhs has been incurred upto 6/87.

(c) and (d) Nearly 70 per cent of the work has been completed so far. The remaining work is likely to be completed by 31-3-83. However, some Horticulture work may continue for some time more beyond 31-3-83.

Programme for rural labourers in Bihar:

THE MINISTER OF STATE IN THE DEPARTMENT OF RURAL DEVELOPMENT IN THE MINISTRY OF AGRICULTURE (SHRI RAMANAND YADAV): (a) National Rural Employment Programme (NREP) and

Rural Landless Employment Guarantee Programme (RLEGP) are the two major rural employment programmes which cover all the areas in Bihar including the drought affected areas.

(b) Resources allocated to Bihar under these two programmes during the year 1986-87 are as under:—

(c) Allocation made under the programmes during the year 1987-88 are as under:—

No allocations for the next financial years have yet been made.

(d) These programmes aim at providing additional employment opportunities to the rural unemployed/under-employed, strengthening the rural infrastructure and improving the overall quality of life in the villages. Part of the wages to the workers under these programmes are paid in foodgrains.
