Gas turbine projects for BHEL

THE MINISTER OF INDUSTRY (SHRI J. VENGAL RAO): (a) and (b) NTPC had floated global Tenders for the equipment for gas based power projects at Anta, Kawas and Auriya. BHEL had submitted their offer for Waste Heat Recovery Boilers and Steam Turbines for these Projects through M|s KWU of West Germany who were the prime bidders. Ministry of Industry had also taken up the matter with Ministry of Energy.

(c) The successful bidders have been advised by NTPC to accommodate BHEL in respect of indigenous procurement of associated equipment (other than gas turbines proper) as far as practicable as per bids keeping in view the World Bank procurement guidelines.

CBI enquiry into NLC contract
