

**Pending Cases of Compensation to  
Bhopal Gas Tragedy Victims**

390. SHRI AJIT P. K. JOGI: Will the Minister of INDUSTRY be pleased to refer to answer to the Unstarred Questions 994 and 1800 given in the Rajya Sabha on the 5th May, 1986 and 11th August, 1986 respectively and state:

(a) how many cases of compensation are still pending in various courts in regard to the Union Carbide gas disaster of Bhopal-

(b) what is the progress of these cases and by when the victims of the aforesaid tragedy are likely to get the compensation; and

(c) whether Government are taking any fresh steps to expedite the disposal of these cases?

THE MINISTER OF INDUSTRY (SHRI J. VENGAL RAO): (a) to (c) The Bhopal Gas Leak Disaster (Processing of Claims) Act, 1985, confers upon the Government the exclusive right to represent and act within or outside India for every person who has made or is entitled to make a claim. The Government of India filed a complaint against UCC in the U.S. Federal District Court, Southern District of New York for recovering damages on behalf of all the victims and persons affected by the Bhopal Gas Leak Disaster. Following the dismissal of this case on grounds of forum non conveniens, a suit was filed by Union of India on behalf of all the claimants in the Court of District Judge, Bhopal.

The District Judge Bhopal has since dismissed the interlocutory application of UCC regarding stay of the proceedings and election of forum by Government of India. On an application filed by Government in the Court of District Judge, Bhopal to restrain Union Carbide Corporation from disposing of its assets, the court directed Union Carbide Corporation (UCC) to maintain unencumbered assets of

a fair market value of \$ 3 billion to meet the decree, if any, that may be passed by the court and has given directions to both the parties regarding preservation of evidence relating to the case.

The Government has also moved an application before the Court for taking up on priority basis, preliminary legal issues on liability of UCC as a multinational enterprise/corporation and holding company to pay damages to the victims and non-maintainability of counter-claim by UCC against Union of India and Government of Madhya Pradesh on the ground of sovereign immunity.

Payment of compensation to the victims could be made only if the case against Union Carbide is decided in favour of Government. The case is in progress and is being pursued vigorously.

**Cooking Gas Facility in U. P.**

391. DR. MOHD. HASHIM KIDWAI: Will the Minister of PETROLEUM AND NATURAL GAS be pleased to state:

(a) the number of cities and towns of Uttar Pradesh which have been provided with cooking gas facilities till June, 1987; and

(b) by when the remaining cities and towns are likely to be provided with this facility?

THE MINISTER OF STATE OF THE MINISTRY OF PETROLEUM AND NATURAL GAS (SHRI BRAHM DUTT): (a) Till June 1987, 109 cities and towns of Uttar Pradesh having population of 20,000 and above have been provided with LPG facility.

(b) 57 towns having population of 20,000 and above are yet to be provided with LPG facility. Out of these, 48 towns have already been included in the various Marketing Plans of the

Oil Industry. Subject to their offering adequate potential for economically viable marketing of LPG, the remaining 9 towns will be taken up for LPG facility from time to time.

**Drugs Under The National Health Programme**

\*392. SHRI RAFIQUE ALAM;  
SHRI RAINI RANIAN SAHU:

Will the Minister of INDUSTRY be pleased to state:

(a) whether the Ministry of Health and family Welfare have recommended to his Ministry the names of drugs required for control of diseases under the National Health Programme; if so, what are the names of those drugs and what action has since been taken in regard thereto;

(b) whether recommendations regarding category II drugs have also been received from the Kelkar Committee and

(c) what are the names of the drugs indicating the basis of and criteria adopted for identification of each drug?

THE MINISTER OF INDUSTRY (SHRI J. VENGAL RAO): (a) Yes, Sir. The Ministry of Health and Family Welfare have given a list of names of drugs required for control of diseases under the National Health Programme. The list which would form Category I drugs to be included in the new Drugs (Prices Control) Order is under examination.

(b) and (c) The Kelkar Committee has submitted its report regarding Category II drugs. The recommendations of the Committee are under examination.

**Performance of BHEL Generating Sets**

Will the Minister of INDUSTRY be pleased to state:

(a) whether Government have made any critical study of the overall performance including maintenance, operational and efficiency problems of BHEL generating sets and other products as compared with imported ones; if so, what are the details thereof;

(b) what is the existing dependency on foreign collaborations in BHEL products and the outgo in the form of royalties and other payments per annum in respect thereof; and

(c) what is the number of generating sets exclusively produced and delivered by BHEL by 1986 and how many of them have been commissioned, indicating their capacity utilisation and their rated capacity?

THE MINISTER OF INDUSTRY (SHRI J. VENGAL RAO): (a) The performance of power generating sets, whether indigenous or imported, depends besides the quality of the equipment, on a number of factors like the quality of inputs, operating skill, proper maintenance practices, etc. Keeping all factors in view, the Central Electricity Authority sets generation targets for various power stations. BHEL sets have exceeded the generation targets set by CEA during 1985-86 and 1986-87, and the first quarter of 1987-88.

(b) BHEL has successfully assimilated technology through foreign collaborations and has developed capability to execute on a turnkey basis thermal and hydro projects and to supply a wide range of equipment in power, industry and transport sectors. However, they enter into foreign collaborations on a selective basis to
