- (c) how many local persons so far been provided employment in Singrauli tehsil of Madya Pradesh while displacing thousands of persons for the construction of Vindhya Nagar Super Thermal Power Station;
- (d) whether Government are aware that recently several persons mostly poor farmers and Harijans, have been thrown out of such employment by Vindhya Nagar Super Thermal Power authorities with the result Station that all these poor families have been left with no means of livelihood; and
- (e) if so, whether Government will honour their earlier commitment and take them back in employment?

THE MINISTER OF STATE IN THE DEPARTMENT OF POWER IN THE MINISTRY OF ENERGY (SHRI-MATI SUSHILA ROHATGI): (a) to (c) In addition to providing compensation for the lands acquired and employment to affected persons, to the extent possible, all efforts are made to rehabilitate them gainfully. The numbers of local persons from State of Madhya Pradesh, who have been provided employment in Vindhyachal Super Thermal Power

Project of the National Thermal Power Corporation, are as follows:—

### World Bank assistance for installing Hydro electric projects

- (a) whether the World Bank has extended a loan of \$ 330 million to instal low cost hydro-power facilities in Karnataka as reported in the 'Hindustan Times' of 10th June, 1987;
- (b) if so, whether the work on the proposed hydro power projects has since been commissioned; and
- (c) by when the work is likely to be completed and to what extent the steep shortage of power in the Southern States is to be met by the proposed project?

THE MINISTER OF STATE IN THE DEPARTMENT OF POWER IN THE MINISTRY OF ENERGY (SHRIMATI SUSHILA ROHATGI): (a) A World Bank loan of US \$ 330 million has been approved for the Karnataka Power Project.
