THE MINISTER OF HUMAN RESOURCE DEVELOPMENT (SHRI . ARJUN SINGH): (a) and (b) The Seventh All India School Education Survey . (7th AISES) conducted by National Council of Educational Research and Training (NCERT) with September 30, 2002 as the reference date has provided data about Pupil Teacher Ratio (PTR) at primary, upper primary, secondary and higher secondary levels of education which were found to be 32.71, 28.34, 27.25 and 28.85 respectively at National level.

Education Is a subject in the Concurrent List. The recruitment of teachers in schools of States/UTs is controlled by the respective State Governments/ UT Administrations. In order to improve *P~i & at* primary and upper primary levels in States with adverse PT R. a total of 10.12 lakh teachers have been sanctioned under the Sarva Shiksha Abhiyan.

THE MINISTER OF HUMAN RESOURCE DEVELOPMENT (SHRI ARJUN SINGH): (a) to (e) The Sarva Shiksha Abhiyan Programme approved in 2001 provided for a 50:50 Centre State fund sharing pattern in the Eleventh Plan period. Most States have requested Government of India to continue with the 75:25 Centre State sharing pattern for the Eleventh Plan period while North Eastern States have requested for a 90:10 sharing pattern. This request was reiterated by the States during the State Education Minister's Conference held in New Delhi on 10-11 April, 2007.

The Department of School Education and Literacy has moved a proposal along the above mentioned lines for consideration by the Government of India.

THE MINISTER OF HUMAN RESOURCE DEVELOPMENT (SHRI ARJUN SINGH): (a) and (b) As per the Seventh All India School Education Survey (7th AISES) conducted by National Council of Educational Research and Training (NCERT) with September 30, 2002 as reference date, out of a total number of 34,91,459 full-time teachers working in recognised schools in rural India, 6,39,905 teachers were found to be untrained.
