

**Price Hike of Ampicilline and Amoscycillin**

3742. SHRI RAJNI RANJAN SAHU: Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

(a) whether Government propose to hike the price of 6 APA an essential drug intermediate of Ampicilline and Amoscycillin; and

(b) if so, the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (SHRIMATI SAROJ KHAPARDE): (a) and (b) As per the information received from the Deptt. of Chemicals and Petrochemicals, Ministry of Industry, the Government have already revised the price of 6-APA from Rs. 1778/Kg. to Rs. 1871/Kg. on 14th August, 1987.

**Railway Land Allotted to Businessmen**

3743. SHRI RAJNI RANJAN SAHU: Will the Minister of RAILWAYS be pleased to state:

(a) whether any railway land has been allotted to businessmen in different parts of the country during the last two years; if so, the details thereof and the reasons therefor;

(b) the estimated market value of such land; and

(c) the steps taken to recover the same?

THE MINISTER OF STATE OF THE MINISTRY OF RAILWAYS (SHRI MADHAVRAO SCINDIA): (a) to (c) The information is being collected and will be laid on the table of the Sabha.

**Rail accident near Birbhum**

3744. SHRI RAJNI RANJAN SAHU: Will the Minister of RAILWAYS be pleased to state:

(a) whether several bogies of a train went off the rails near Birbhum in West Bengal recently, if so, the details thereof;

(b) whether this was due to poor maintenance of rail track; and

(c) if so, the steps taken for their proper maintenance?

THE MINISTER OF STATE OF THE MINISTRY OF RAILWAYS (SHRI MADHAVRAO SCINDIA): (a) Yes, Sir. At about 13.00 hours on 27-7-1987, while 316 Dn. Barharwa-Rampurhat Passenger was running between Murarai and Chatra stations of Eastern Railway, 5 bogies derailed over bridge No. 201. Of the derailed bogies, 2 fell into the river bed.

(b) and (c) No, Sir. As per Provisional Finding of the Commissioner of Railway Safety, Eastern Circle, the accident occurred due to snapping of safety bracket of a coach and falling on the track.

**Chemist stall /shop at Delhi and New Delhi Railway Stations**

3745. SHRI N. RAJANGAM: Will the Minister of RAILWAYS be pleased to state:

(a) whether the facility of Chemist stall | shop is provided at Delhi and New Delhi railway stations, if not, the reasons therefor;

(b) whether applications/tenders were called for the provision of such stalls, if so, the details thereof; and

(c) what kind of items can be permitted for sale at such stalls shops?

THE MINISTER OF STATE OF THE MINISTRY OF RAILWAYS (SHRI MADHAVRAO SCINDIA): (a) No, Sir. At present there is a ban on increase in number of stalls] trolleys etc. due to congestion on platforms.

(b) In 1983, applications were invited by Northern Railway for allotment of a chemist stall at New Delhi station, but no allotment was made as none of the applicants was found suitable.

(c) Medicines, toilet/cosmetic items, jams, squashes and items like Hor-lick, Bournvita and Ovaltine can be sold from chemist stalls.

#### **Shortage of Platforms at Delhi Junction**

3746. SHRI N. RAJANGAM: Will the Minister of RAILWAYS be pleased to state:

(a) what arrangements have been made for non-detention of the trains at the outer singal due to shortage of vacant platforms at Delhi Railway Junction;

(b) whether it is a fact that due to increase in passenger traffic the Northern Railway has reported regularly to the Board for construction of more passenger platforms at Delhi Junction; and

(c) if so, what action has been taken thereon?

THE MINISTER OF STATE OF THE MINISTRY OF RAILWAYS (SHRI MADHAVRAO SCINDIA): (a) Necessary steps, including route relay interlocking, electrification, extension of platforms and augmentation of maintenance facilities have been taken.

(b) No, Sir

(c) Does not arise.

#### **Construction of Passenger Platforms at Railway Stations**

(a) what are the names of stations where new passenger platforms were

constructed during the last three years, year-wise, in each Zonal Railways;

(b) the names of the stations where the goods | parcel platforms converted into passenger platforms year-wise in each Zonal Railways during the same period; and

(c) the names of stations where metre-gauge platforms have been converted into broad gauge platforms from July, 1984 to June, 1987 in each Zonal Railways?

#### **Passenger Amenities on National Highways**

(a) what sites earmarked and proposal received regarding setting up of passenger amenities on National Highways in the country and the names and addresses of the parties who have submitted the proposals and sites requested, party-wise; and

(b) whether it is a fact that his Ministry have not received good response, if so, whether the date for the receipt of proposals have been extended, if so, the details thereof and if not, the reasons therefor?

THE MINISTER OF STATE OF THE MINISTRY OF SURFACE TRANSPORT (SHRI RAJESH PILOT): (a) and (b) Initially 52 offers were received from private parties for location of passenger amenities on National Highways. After initial screening, 39 parties
