## SHRI MOSTAFA BIN QUASEM:

Will the Minister of DEFENCE be pleased to state:

- (a) what are the projects pending with Defence Research and Development Organisation, which are nearing completion;
- (b) by when these would be in service with Defence forces; and
- (c) by when DRDO is likely to be able  $t_{\rm O}$  make the country free from foreign markets for vital defence items?

THE MINISTER OF STATE IN THE DEPARTMENT OF DEFENCE PRODUCTION AND SUPPLIES IN THE MINISTRY OF DEFENCE (SHRI SHIV-RAJ PATIL): (a) The number of staff projects nearing completion in the near future is eighty-four. These include projects in the field of Armament, Aeronautics, Electronics, Engineering, Naval R&D materials & food technology.

- (b) Most of the items/stores/equipment developed as a result of work on these projects are likely to be introduced in Defence Services within three years.
- (c) The technology in respect of weapon systems equipments is continuously changing and Defence Services will always be wanting to replace earlier weapons equipments with new generation State-of-art technology system. In order to keep pace with the continuously changing technology, perspective plans have been drawn up by DRDO for advanced technology development in selected areas. The objective of the perspective plan is that by the end of the present century, the nation would not have to depend on import of defence systems for lack of indigenous

capabilities.
