## Production of Fruit Products

- (a) whether Government have set up a few processing units to use fruits for preparing soft drinks and other fruit products; and
- (b) if so, whether production of such items had gone up during the last three years and if not, the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF FOOD AND CIVIL SUPPLIES (SHRI GHULAM NABI AZAD): (a) The Department of Food in the Ministry of Food and Civil Supplies set up a fruit juice bottling plant at Delhi to manufacture fruit drinks. This plant was transferred to Modern Bakeries Limited (subsequently renamed Modern Food Industries (India) Limited) in April 1982, and was commissioned by the Company the same month.

(b) The production figures of fruit drinks manufactured by the plant during the last three years are given below.

Year	Production (in lakh crates—each crate of 24 bottles of 200 ml, each)
1984-85	6.05
1985-86	7.24
1986-87	6.75 (Provisional)

The decline in production 1986-87 was due mainly to frequent break-downs of the plant.
