gallons of water from the Karwan tank into the Upper Lake. The State Government are also reported to have added 115 tubewells with handpumps to serve the drinking water needs of the residents of Bhopal city.

(c) and (d) The Govt. of Madhya Pradesh have been sanctioned in February, 1987 an amount of Rs. 6.66 crores (Rs. 1.35 crores for urban sector and Rs. 5.31 crores for rural sector) for drinking water during 1986-87 and 1987-88 (upto 30.6.87).

## Brackish Water fishing

- \*99. SHRI CHITTA BASU: Will the Minister of AGRICULTURE be pleased to state:
- (a) whether Government have any comprehensive scheme to improve the Brackish Water Fishing in Pambon areas of Rameshwaram island; and
- (b) if so, the details of the scheme and the stage of its implementation?

THE MINISTER OF AGRICULTURE (SHRI G. S. DHILLON); (a) Under the Drought Prone Area Programme, the Tamil Nadu Government have sanctioned a scheme to improve Brackish Water Fish Farming in the Pambon area of Rameshwaram island.

(b) The scheme, sanctioned in 1985, envisages the development of 10 hectares of brackish water fish farm at an estimated cost of Rs. 13.50 lakhs. The civil works for the scheme are yet to begin because of the delay in the transfer of the land from the Revenue to the Fisheries Department of the State Government.
