Production of oil from rice bran

700. SILLI B. SATYANARAYAN REDDY: Will the Minister of FOOD AND CIVIL SUPPLIES be pleased to state:

- (a) what is the total installed capacity of the rice bran refineries set up in the country to produce edible oil from rice bran;
- (b) the total quantity of rice bran oil produced during the year 1986-87;and
- (c) whether it is a fact that the rice bran refineries are facing a closure due to lack of encouragement from Government?

THE MINISTER OF PARLIAMENTARY AFFAIRS AND THE MINISTER OF FOOD AND CIVIL SUPPLIES (SHRI H. K. L. BHAGAT):
(a) Government authorisation is issued generally for refining of vegetable oils including rice bran oil.

Manufacturers may or may not refine rice bran oil. As per the Report of the Working Group on Edible

Oils for the 7th Five Year Plan, the total annual capacity of the refineries in the country is estimated at around 20 lakh tonnes.

- (b) About 2.57 lakh tonnes.
- (c) Incentives have been provided by Government for production of rice bran oil.

THE MINISTER OF AGRICUL-(SHRI G. S. DHILLON): TURE. (a) National Cooperative Development Corporation (NCDC) had provided total assistance of Rs. 966.97 lakhs to NAFED comprising Rs. 885.26 lakhs as loan Rs. 40,00 lakhs as share capital and Rs. 41.71 lakhs as subsidy up to 30th June, 1986. Government had invested in amount of Rs. 18.00 lakhs as share capital and Rs. 510.90 lakhs as loan as on 30th June, 1986. NAFED is the Central Nodal Agency for price support operations undertaken in collaboration with the State designed Agencies for which cent percent losses are met by the Government in case of oilseeds. Cengives on account tral Government advances to NAFED to meet losses an as on 30th June, 1986 such advances stood at Rs. 204.93 lakhs.

(b) The Audit observations for the year 1985-86 do not point out any

misappropriation of funds by appropriating in admissible expenditure under Staff Welfare Account Head. NAFED books the expenditure under various Heads in accordance with the definition given in NAFED's Accounting Manual. The General Body of NAFED which met on 12-3.1987 esp. sidered the Audit Report.

Irrigation in Orissa

703. SHRI BASUDEB MOHAPAT-RA: Will the Minister of WATER RESOURCES be pleased to state:

- (a) the area of land brought under irrigation in the years 1985 and 1986 and proposed to be brought under irrigation during 1987-88 in Orissa in general and Kalahandi, Balangir, Phulabani and Mayurbhanj districts in particular;
- (b) the details of financial assistance to be given for the areas proposed to be brought under irrigation during the year 1987-88; and
- (c) the total amount allocated and spent in the years 1985 and 1986 in the aforesaid districts?

THE MINISTER OF WATER RESOURCES (SHRI B. SHANKARANAND): (a) During the years 1985-86 and 1986-87, an additional area of about 92 th. ha. was brought under irrigation in Orissa (anticipated). The target for 1987-88 is 67.50 th. ha. District-wise details are not maintained at the Centre.

- (b) No special financial assistance is given. Central assistance is given in the form of bloc loans and grants and is not tied to any scheme or sector of development. The agreed Plan outlay for major, medium and minor irrigation projects in Orissa for 1987-88 is Rs. 185.38 crroes.
- (c) The total approved outlay for major-medium and minor irrigation schemes in Orissa for two years of 1985-86 and 1986-87 were Rs. 246.70 crores. The anticipated expenditure
