## Impact of delayed Monsoon on Drinking Water and Agriculture Operation

SURESH 704 SHRT KALWADI: Will the Minister of AGRICULTURE be pleased to state:

- (a) whether it is a fact that the delay in the onset of monsoon is causing worry in various States, particularly in northern India;
- (b) if so, he details of the affected States and the prevailing water shortage and drought conditions as result thereof:
- (c) the measures being taken Government to face this situation: and
- (d) the impact of the situation on water and drinking agricultural operations during the current season?

THE MINISTER OF STATE THE DEPARTMENT OF AGRICUL-TURE AND COOPERATION IN THE MINISTRY OF AGRICULTURE (SHRI YOGENDRA MAKWANA): (a) and (b) Due to erratic behaviour of the South-West monsoon this year, the States of Rajasthan, Gujarat: Tamil Nadu; U.P.: Madhya Pradesh and Union Territory of Pondicherry have reported drought conditions so far.

(c) The concerned State Governments take up the necessary steps to combat the situation arising out the drought conditions as per established procedure. Government India only supplement the tfforts of the State Government to tackle the situation effectively. Ministry Agriculture has requested the State Governments to give highest priority to the provision of electricity and diesel to operate agriculture pump sets. A Special Conference was held on 28-7-1987 by Ministry of Agriculture to chalk out further course of action to make the best use of available moisture and to review the situation. It was decided that the State

Governments would apply their contingency plan for sowing alternate short duration crops in areas affected by delayed rains

(d) It is too early to assess the impact of the behaviour of the current monsoon on drinking water situation and agricultural operations.
