- whether Government have made any allocation of funds to help the various states to tide over the (serious situation; and
 - (d) if so, the details thereof?

OF THE MINISTER STATE DEPARTMENT OF THE AGRICUL TURE AND COOPERATION IN THE MINISTRY OF AGRICULTURE (SHRI YOGENDRA MAKWANA): (a) Due to erratic behaviour of the year,' South-West monsoon this the States of Rajasthan Gujarat, Tamil Pradesh Nadu and Madhya have conditions reported drought and the Government of Uttar Pradesh has also reported about developing the Reports of drought situation. mois shortage ture stress of and water have also been received Union Territory of Pondicherry.

(b) to (d) Relief to affected farmers is extended by the respective State Governments and the Central Government extends need based assistance to the State Governments at the latter'g request. Government of India maintains close lioison with the State Governments concerned and supplement their efforts with a view to mitigate the distress of affected people. The concerned State Governments have taken up employment generation programmes acceleration of water supply programmes, transportation of drinking water to areas where sources of drinking water is not available, transportation of fodder from surplus areas to the drought affected areas for cattle conservation, etc. Central Government besides providing technical and financial assistance to the States for improving rural water supply has also launched a "Technical Mission on Drinking water in

villages and 'related Water Management" scheme. The areas selected for taking up 'Mini Mission Pilot Project' under the Technical mission in 1986-87 also include areas known for pro longed drought, such as Kutch in M.P., Gujarat, Jhabua in Gulberga in Karnataka, Mirzapur in U.P. Bankura in West Bengal.

A ceiling of expenditure to the tune of Rs. 226.43 crores have so far been approved for tackling drought conditious during 1987-88 in 'respect of 9 States including Gujarat, Rajasthan, Tamil Nadu and Madhya Pradesh. In addition, 5.00 lakh M.T. wheat has been allocated during 1987-

88 to the States of Rajasthan Ma dhya Pradesh and Gujarat for distri bution to the workers engaged in drought relief works.

THE MINISTER OF STEEL AND MINES (SHRI M. L. FOTEDAR): (a) and (b) Steel materials are distributed in terms of the Distribution

Guidelines of the Joint Plant Committee (JPC) of main producers. These guidelines do not provide for Zone-wise or Yard-wise allotment of steel. In the case of Status 'A' consumers such as Defence, Railways, major Central Government Departments/ Undertakings, etc. materials are supplied against the allocations made by JPC, at present. The remaining: consumers received materials against demand registrations. The quantity of steel supplied from the Northern Zone of SAIL comprising stockyards located a New Delhi, Faridabad, Gha-ziabad Agra and Gwalior, during the last two years is shown in the Annexure (See Appendix CXLIII, Annexure No. 42).

- (c) The details of stocks lying in the branches in the No'rthern Zone of SAIL at the end of the last two years are shown in the Annexure (Sec Apendix CXLIII Annexure No. 42.]
- (d) There is no Branch Manager or Executive working for more than four years in a particular stockyard/ branch of SAIL.
- (e) During the last one year, one recorded complaint each has been received against the Executives in the yards of SAIL of New Delhi, Gha-ziabad and Agra. These have been investigated and action where consi dered necessary taken. In addition, *Some* complaints rtegJarding discrepancy in weighments etc. had been-'received by SAIL and these were dealt with on merits by the Branch Offices concerned

- (t) Following the suicide of Dr. V. H. Shah a Committee under the Chairmanship of Dr.. P. B. Gajendra-gadkar Ex-Chief Justice of India was constituted to probe into the working of the ICAR system.
- (c) The recommendations of the Gajendragadka'r Committee mostly relate to the organisational structure and personnel policies of ICAR. The Government have already implemented the recommendations with slight modifications.
