Affairs specifically carry out the special interventions for empowerment of the Scheduled Castes/Scheduled Tribes. The items directly concerning the welfare of SCs/STs comprise of affirmative action including reservations in Private Sector and legislation for conferring ownership rights in respect of minor forest produce, rights of tribal and other forest dwelling communities over mineral & water sources in the forest areas and other socio-economic and environmental issues.

On the issue of affirmative action including reservations for SC/ST youth in the Private Sector, the dialogue is continuing with the Industrial Organisations. In order to redress the problems of ownership rights and eviction in respect of the tribal communities and other forest dwelling communities dependent on forests, "The Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006" has been enacted.

Entry of foreign law firms

Shortage of teachers in schools

of Seventh All India Education Survey which states that there is a shortage of teachers in the schools throughout the country; and

(b) if so, the details of the report and the measures taken to meet the shortage of teachers?

THE MINISTER OF HUMAN RESOURCE DEVELOPMENT (SHRI . ARJUN SINGH): (a) and (b) The Seventh All India School Education Survey . (7th AISES) conducted by National Council of Educational Research and Training (NCERT) with September 30, 2002 as the reference date has provided data about Pupil Teacher Ratio (PTR) at primary, upper primary, secondary and higher seconday levels of education which were found to be 32.71, 28.34, 27.25 and 28.85 respectively at National level.

Education Is a subject in the Concurrent List. The recruitment of teachers in schools of States/UTs is controlled by the respective State Governments/UT Administrations. In order to improve $P \sim i$ & at primary and upper primary levels in States with adverse PT R. a total of 10.12 lakh teachers have been sanctioned under the Sarva Shiksha Abhiyan.
