(SHRI H. R. EHARDWAJ): (a) A permanent Bench of ithe Bombay High Court was established, at Aurangabad in Maharashtra in August, 1984. No other Bench of the High Court has been established in any State during the last three years.

(b) Pending the formation of separate High Courts for the States in the north eastern region through Central legislation it has been decided to establish permanent Benches of the Gauhati High Court in the capital of these States. These Benches could be set up after the State authorities have made the necessary arrangements for accommodation etc.

Proposals fo,r establishment of Benches of the Allahabad Karnataka Madhya Pradesh and Madras High Courts were received from the concerned State Governments, The recommendations of the Jaswant Singh Commission were referred to ithese State Governments for their views and comments. No reply has *o far been received from any State Government.

No other proposal for establishment of a Bench of a High Court has .been received from any State Government.
