THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI EDUARDO FALEIRO): (a) and (b) At a press conference held in Beijing on April 3, 1987 the Chinese Vice Foreign Minister Qian Kichen, stated as follows:

"The Chinese Government has made it clear on many occasions that it is a historical fact that Tsarist Russia had occupied part of Chinese territory through unequal treaties and that the Chinese Government is willing to resolve the Sino-Soviet boundary disputes on the basis of the existing treaties".

(c) Regarding the Sino-Indian boundary Government are of the view that this boundary is based on custom and tradition follows natural feaures. and for the major part this customary and traditional boundary is also confirmed by Treaty and Agreement.
