Rail Traffic between Madras and Madurai

(b) Karur-Dindigul new B.G. line and Dindigul-Madurai parallel B.G. line is part of the approved project for BG rail link from Karur to Tuti-

There is no proposal to convert the existing M.G. route to B.G.
