- (a) what are the plans to open Navodaya Vidyalayas during 1st June, 1987 to 30th December, 1988 in Rajkot, Bhavnagar, Valsad, Baroda; Amreli Districts of Gujarat; and
- (b) what is the quota fixed for the Scheduled Castes or Scheduled Tribes, girls an other weaker sections in these Vidyalayas?

THE MINISTER OF STATE IN DEPARTMENTS OF EDUCATION AND CULTURE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (SHRIMATI KRISHNA SAHI): (a) So far tw_0 Navodaya Vidyalayas have been sanctioned to be established in the district? of Surat and Bharuch in the State of Gujarat.

(b) Reservation of seats in favour of children belonging to the Scheduled Castes and Scheduled Tribes will be provided in proportion to their population in the concerned district, provided that in no district will such reservation be less than the national average. If sufficient number of children of one of these two categories do not qualify, it would be possible to interchange seat between the two categories. Necessary improvisation will be made in the testing techniques to ensure that SC/ST childeren secure admission in Navodaya Vidyalayas in accordance with the reservations laid down for them.

Efforts will be made to ensure that at least one-third of the students in each Navodaya Vidyalay_a are girls.

C.P.F./G.P..F. Account of N.D.M.C. Teachers

- (c) what steps Government are taking to direct N.D.M.C to up-date those entries?

THE MINISTER OF STATE IN THE DEPARTMENTS OF EDUCATION AND CULTURE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (SHRIMATI KRISH-NA SAHI); (a) G.P.F. Account entries have been made upto 1984-85 in the pass books issued to the subscribers.

The accounts for 1985-86 have been closed and annual G.P.F. statements will be issued shortly. The C.P.F. entries in pass books of C.P.F. subscribers have been made upto 1978-79.

- (b) C.P.F. and G.P.F. accounts had fallen in arrears due to adoption of pension scheme involving segregation of employees' and employer's portion on subscription from C-P-F. (involving recasting of accounts *ab-initio*.
- (c) The accounts of C.P.F. subscribers are expected to be completed upto 1984.85 by the end of June, 1987. The accounts for 1985-86 are also expected to be closed by the end of August, 1987. N.D.M.C. is making all efforts to make G.P.F. and C.P.F. accounts of subscribers upto date.
