Irregularities in Vishwayatan Yogashram, Ashok Rozd, New Delhi

(a) whether the inquiry report submitted to his Ministry a couple of months ago, found Vishwayatan Yogashram, Ashok Road, New Delhi guilty of irregular practices; if so, what are the details thereof;

(b) whether it is a fact that the Yogashram introduced a three month course without the approval of his Ministry and has also terminated the services of several of its employees without following the set procedures;

(c) whether it is also a fact that the salary for January, February and to Questions

March, 1987 has not been disbursed to some of their staff members; and

(d) if so, the action taken or proposed to be taken by Government in this regard?

THE MINISTER OF HUMAN RE-SOURCE DEVELOPMENT AND THE MINISTER OF HEALTH AND FA-MILY WELFARE (SHRI P. V. NARASIMHA RAO): (a) The inquiry report is under examination.

(b) The 3 months course was introduced by Yogashram before the management of the Institute was taken over by the Ministry of Health w.e.f 24.5.1977. Prior to this date, the institution was receiving assistance from the Ministry of Education. The Institute is a private registered society. The procedure for termination of services for Govt. employees does not apply to the employees of the Institute.

(c) No, Sir.

(d) Does not arise.

Security Arrangements at Airports

These security arrangements have been designed to regulate entry of persons and vehicles, to ensure security of registered baggage and the aircraft and to minimise the possibility of a pass[6 MAY 1987]

enger carrying a weapon on his person|hand-baggage. The objective is to ensure that there is no unlawful interference with civil aviation.

Financial crisis in Vayudoot

(a) whether Government are aware of the fact that the Vayudoot service is heading for a financial crisis; and
