- (a) whether it is a fact that Government of India's Instructions provide for proceedings under CCS (CCA) Rules 1965 against officers whose failure to observe proper procedure results in reinstatement of dismissed/removed employees;
- (b) if so, what has been the number of disciplinary cases in Kendriya

Vidyalaya Sangathan wherein such failure on the part of Disciplinary Authority/Inquiry Officers to observe proper procedure in the enquiry resulted in the reinstatement of punished employees by Courts or Appellate Authority during the last three years;

- (c) whether any Kendriya Vidyalaya Sangathan Officer has been proceeded against CCS (CCA) Rules on this count; and
- (d) if so, what are the details thereof and if not, what are the reasons therefor?

THE MINISTER OF STATE IN THE DEPARTMENTS OF EDUCATION AND CULTURE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (SHRIMATI KRISHNA SAHI): (a) Yes, Sir. The Government instructions provide action against officials who fail to observe proper procedure wilfully or due to gross negligence.

- (b) There is no case in the Sangathan where the Disciplinary Authority or Inquiry Officer failed to observe the procedure wilfully or owing to gross negligence.

AIDS Victims in the Country

1767. FHRI HARVENDRA SINGH HANSP! L: Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

- (a) what is the number of AIDS victims reported in India as on 31st March, 1987;
- (b) what further steps are contemplated by Government to keep off this disease from the country; and
- (c) whether Government's attention has been drawn to a news item under the caption "5m infected by AIDS world-wide WHO" as reported in the 'Hindustan Times' dated 25th March, 1987?

THE MINISTER OF HUMAN RESOURCE DEVELOPMENT AND THE MINISTER OF HEALTH AND FAMILY WELFARE (SHRI P. V. NARASIMHA RAO): (a) Upto the end of 31st March, 1987, a full blown cases of AIDS have been reported in India of which 5 are Indians, one is a non-resident Indian and other three are foreigners.

- (b) The following steps are being taken by the Government:—
 - 1. 27 Surveillance centres have been established in the country to screen high risk group. In addition, 3 referral centres where higher level diagnostic facilities for AIDS are available, have been set up.
 - 2. Restrictions have been imposed for import of blood and blood products without AIDS clearance Certificate.
 - 3. All the State Health authorities/hospitals/STD Clinics have been alerted to look for AIDS cases.
 - 4. All the banks have been instructed to screen the professional blood donors.
 - 5. All the State Health authorities have been advised to ensure strict sterilisation practices in hospitals and clinics or to use presterilised disposable syringes and needles as far as possible.
 - 6. Guidelines have been sent to all the State Health authorities for health care personnel.
- 7. All the mass media channels have been involved in educating the people on AIDS, its nature, transmission and prevention.
 - 8. Screening of all foreign students for AIDS made mandatory.
