

2. All Sulpha drugs and anti-histamic drugs.

3. Erythromycin/Tetracycline.

These drugs are used only after the laboratory test confirmation. Except Penicillin and Streptomycin, other drugs do not require any sensitivity test of the patients.

Grant for purchasing sophisticated medical equipment in Karnataka

290. SHRI D. B. CHANDRE GOWDA; Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

(a) whether the Government of Karnataka has urged the Central Government to sanction Rs. 30 lakhs for the purchase of sophisticated and modern equipment for use in the hospitals in that state;

(c) The Government of Karnataka have been informed that at present, there is no scheme under which such assistance could be provided to them.

(c) and (d) Navodaya Vidyalayas have been started only recently. They do not have computers yet.

(e) and (f) No separate funds were earmarked for providing computers in Navodaya Vidyalayas in the budget for 1986-87.
