Delay in clearance of Cargo at Indira Gandhi International Airport

- (b) the number of bills of entry were filed for he imported carog at this airport during 1986^-87 and how many of them were cleared by the customs within one week, two weeks, three weeks and above; and
- Cc) what are the Government instructions to the customs for the timely clearance of cargo at this airport?

THE MINISTER OF STATE OF THE MINISTRY OP PETROLEUM AND

NATURAL GAS AND THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI BRAHM DUTT). (a) Yest Sir, The delay in clearance of import cargo at the Indira Gandhi International Airport is mainly attributable to late receipt of cargo arrival notices by the importers from the respective Airlines. So far as the Customs Authorities are concerned they process the import documents expeditiously and about 65 per cent docur ments are cleared by them within 48 hours.

- (b) The number of bills of entry filed for the import cargo at the Indira Gandhi Airport during 1986-87 was 71436, In 95 per cent cases, the bills of entry were processed and finalised within a week of the filing of the bills of entry. In the rest of the cases, the clearance is delayed on account of tnquiries with regard to declaration made by the importers and adjudication wherever necessary.
- (c) The instructions on the subject require that in cases where the documents are complete and which do not involve any dispute regarding import permissibility or acceptance of value declared the assessment should be completed within 48 hours of the filing of the bill of entry.
