As his request could not be acceded to, the Director of Doordarshan Kendra, Calcutta had conveyed the message that Education Secretary or President of Board of Secondary Education could talk instead of the Minister. The Doordarshan Kendra, Calcutta had headlined the news regarding the postponement of Secondary Examination on 24-2-1987. The news quoted Shri Kanti Biswas, State Minister of Secondary Education which mentioned looting of question papers at Mirik (Darjeeting) as the cause of postponement. The Statement of Chief Minister at Midnapore was telecast on 25-2-1987 in which it was mentioned that decision of the said examination due to loot was taken at Cabinet level. In addition announcements regarding postponement of examination was telecast twice on 25-2-1987 and once each on 26-2-1987 and 27-2-1987.

Boycott of AIR and Doordarshan for Election Propaganda

2011. SHRI SUKOMAL SEN: Will the Minister of INFORMATION AND BROADCASTING be pleased to state:

- (a) whether it is fact that the ruling Left Front in West Bengal boycotted the All India Radio and Doordarshan for election propaganda during the accent Assembly elections in West Bengal;
- (b) what was the nature of complaint of the Left Front against these official media; and
- (c) what steps the Government propose to take against these complaints?

THE MINISTER OF STATE OF THE MINISTRY OF INFORMATION AND BROADCASTING (SHRI AJIT PANJA): (a) and (b) Yes, Sir. The Ruling Left Front in West Bengal boycotted the pre-election party political broadcast by All India Radio and TV because their complaint was that the two official media were either blacking out news about Left Front or distorting them.

(c) The complaints were examined and it was found that they have had no basis and found to be incorrect.

THE MINISTER OF STATE IN Tiffe MINISTRY OF FINANCE (SHRI JANARDHAN POOJARI): (a) and (b) No., Sir. Kanpur D visional Office of LIC has settled 1114 out of 1378 quath claims between 1-4-86 and 28-2-87.

- (c) and (d) No, Sir. Out of four death claims under "Jeevan Mara" polices during the year 1986-87 are claimated been fully setated by Kanpua Division of LIC. Basic sum assured under one policy has been paid but double accident benefit claim under that policy is pending for want of police report sought from the claimant. The remaining two claims are early death claims requiring investigation as per usual procedure.
- (e) The LIC has taken the following steps for expeditions settlement of deata claims:—
- (i) Dispensing with production of age proof upto sum assured of Rs. 20,000 if the life assured s age at eachy has not been admitted.
- (ii) Dispens ng with indemnity bond for loss of original policy document upto certain limit.
- (iii) Waiver o, legal evidence of title to the estate of the deceased life assured upto certain limit.
- (iv) Decentralisation of claim settlement function to Branch Offices.

THE MINISTER OF STATE OF THE MINISTRY OF PETROLEUM AND NATURAL GAS AND THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI BRAHM DUTT); (a) and (b) Government had issued guidelines on the floating of debentures from time to time. In the guidelines issued on 15th September, 1984, it had been prescribed that only secured debentures would be permitted for issue to the public. The creation of security for the debenture was in the interest of debenture holder and necessitated the creation of a Trust and the appointment of the Trustee In the guidelines issued on 14-1-1987, Government have prescribed the creation of a Debenture Redemption Reserve and expanded the role of the Trustees to facilitate the serviceability and repayment of debentures to the debenture-holders on time.

(c) In June, 1986 Government decided that hence forth conversion of non-convertible debentures and the non-convertible portion of partially convertible debentures would not be permitted. The application of M/s. Reliance Industries Limited could not be approved in view of the general decision taken by Government to ban such conversion.
