

लोक नायक जयप्रकाश नारायण अस्पताल, नई दिल्ली के समीप तल-मार्ग (सबरे) में अंधकार और गंदगी

2266. श्री सुनील कुमार पट्टनायक : क्या शहरी विकास मंत्री यह बताने की कृपा करेंगे कि :

(क) क्या यह सच है कि लोक नायक जयप्रकाश नारायण अस्पताल, नई दिल्ली के समीप निर्मित तल-मार्ग (सबरे) में अत्यधिक गंदगी और रात्रि के समय घना अंधकार होने के कारण आम जनता को भारी अनुविधा का सामना करना पड़ रहा है; और

(ख) यदि हां, तो इसके क्या कारण हैं और इस संबंध में सरकार क्या कदम उठाने का विचार रखती है ?

शहरी विकास मंत्रालय में राज्य मंत्री (श्री बलदेव सिंह) : (क) दिल्ली नगर निगम ने सूचित किया है कि :—

(i) भूमिगत मार्ग में प्रकाश की व्यवस्था है तथा यह कार्य कर रही है ; और

(ii) इस भूमिगत मार्ग में कोई गंदगी तथा कचरा नहीं है जिसकी निरंतर सफाई की जा रही है और जिसे अच्छी स्थिति में बनाए रखा जा रहा है ।

(ख) प्रश्न ही नहीं उठता ।

Construction of Community Centres/ Halls in Janak Puri, New Delhi

2267. SHRI BHAGATRAM MANHAR: Will the Minister of URBAN DEVELOPMENT be pleased to state:

(a) whether it is a fact that work of the construction of Community Centres/halls in each Block of Janak Puri, New Delhi has been delayed;

(b) if so, what are the reasons therefor; and

(c) by which dates these community halls/Centres are likely to be completed?

THE MINISTER OF STATE IN THE MINISTRY OF URBAN DEVELOPMENT (SHRI DALBIR SINGH):

(a) to (c) Sites have been allotted for the purpose in blocks A & C of Janakpuri. In

both the cases, the possession of land could not be handed over by the DD, due to non receipt of payment of the cost of land. Suitable provision for the community halls will be made in the layout plans of the other blocks. According to the policy of the DDA the cost of construction of community halls will have to be borne by the allottees. The Welfare Associations are at liberty to get the work executed through the DDA after making the payment of the cost of construction or alternatively after getting possession of the land they could do the construction themselves. It is not

possible at present to indicate the time by which the community halls are likely to be completed.

(a) the number of persons who got themselves registered for the allotment of flats under the HUDCO pattern 1979 scheme, category-wise;

(b) the number of persons who have been allotted flats in each category so far;

(c) what is the number of flats under different categories, Janata, LIG & MIG, category-wise and locality-wise which are at present under construction in Delhi under the HUDCO pattern 1979 scheme and what is the likely cost of each flat, category-wise and locality-wise; and
