THE MINISTER OF STATE IN THE DEPARTMENT OF AGRICULTURE, /. ND COOPERATION IN THE MINISTRY OF AGRICULTURE (SHRI YO-GENDRA MAKWANA): (a) The Di-rsctor, Indian Agricultural Research Ins-f ute (IARI) issued instructions to Pro-ejct Coordinator (Barlev), IARI Regional Station, Karnal to sanction leave, arrange disbursement of withheld salary

and GPF advance etc. to the aggrieved employees.

- (b) Yes, Sir.
- (c) The staff transferred are: —Scien tists 2, Technical Assistant 2 and Senior Cleark 1.

The transfers were made for administrative reasons to casure smooth working of the Regional Station.

Share of Saurashtra region from Sardar Sarovar project

- (c) the details of the -; ources of finance for Sardar Sarovar Project including the
- ' terms on which finance is to be received with interest factor;
- (d) the annual interest Goveinment are likely to pay en the above project during the project period; and
- (e) what is the likely annual interest on the above project and how much depreciation is likely to be considered every year on above project after it is completed, other than the cost on power generating facility?

THE MINISTER OF WATER RE-SOURCES (SHRI B. SHANKARA-NAND): (a) The project envisages supply of 8. 2 MAFT. of water annually for irrigation in Gujarat, of which, 1. 65 MAFt. is for Saurashtra.

- (b) The annual recurring costs have not been separately worked out.
- (c) to (e) The project will be financed from the State Plan resources. In addition, world Bank is to provide an assistance of dollar 250 million through TDA credit and a loan, of dollar 200 million. For

loan, the interest at present is 7. 92 per cent per annum, but may vary from year to year. The life of the project lias been taken as 100 years for working out the depreciation.

THE MINISTER OF STATE IN THE MINISTRY OF FOOD AND CIVIL SUPPLIES (SHRI GHULAM NABI AZAD); (a) NCCF has reported that it has suffered a loss of Rs. 10. 49 lakhs in the sale of imported chick peas in 1984.

(b) NCCF has also reported that the stock of chickpea_s was imported ort the basi_s of an indent from Taj Consmuei Cooperative Society of Bombay who after lifting a small quantity failed to lift the balance stock. NCCF thereafter sold the balance stock to a private firm Rs. 5300 per MT resulting in a loss. The entire dear enquired into by the tnen Additional Managing Director-cuc-Chief Consultant of NCCF who held that the then Chief Manager (Import and Export). Chief Controller of Accounts & Finance. former Addl. Managing Director and Managing Director were individually and collectively responsible for the various irregularities and lapses deal, i The services of the Chief Manager (Import & Export) were terminated by the NCCF and the Chief Controller of Accounts and Finance, Addl. Managing Director Managing Director were repatriated to their parent offices, who have been advised by the NCCF by the NCCF to take appropriate action against them.
