Processed foods and milk products also differ with regard to the class of consumer they cater to.

(c) Excise duty on processed food industry is not being removed because of its nominal rate. Similarly, excise duty on packaging is not exempted because of its numerous uses other than food industry.

Modernisation of mini steel plants
