The new measures aim at ensuring, -abundant availability, on a continuous basis; at reasonable prices of essential, life saving and prophylactic medicines of good quality. These measures *inter-alia* provide for incentives to encourage production pf essential and life saving drugs.

OF ENERGY (SHRIMATI SUSHILA ROHATGI); (a) to (d) Information in respect of proposals submitted by the State authorities for setting up of thermal power projects and the present status thereof is contained in the enclosed Statement. (See below).

Linkage of coal and gas for proposed projects has to be related to projections of their availability i_n the relevant time-frame and relative priority of projects keeping in view, -inter alla, the power requirements of Region/ State.

The proposals received can be considered for approval after all necessary inputs, including financial resources, have been tied up and requlsite clearances, such as from the environmental angle, have become available.
