(b) The proposals for foreign travel are examined according to the guidelines issued by the Government. Ministry of Finance have issued detail-instructions for processing and approval of all cases involving foreign travel by officials in this regard.

<c) Foreign travel is undertaken only in connection with specific projects and—for attending important meetings and conferences. - Some of these are financed by United Nations agencies also. Foreign travel is not allowed to the detriment of normal programmes of the. Government.

(d) The programmes are under constant review. National Project for Biogas Development and National Programme on Improved Chulhas are also evaluated by independent agencies. Project for Biogas Development, National Programme on Improved Chulha, Street lighting through solar photq-voltales integrated energy centres, namely, Urjagrams etc. are already making an impact on the quantitative and qualitative upgrada-tion of the standard of living of the people in rural areas. These Programmes have become very popular in the rural areas.

THE MINISTER OF STATE IN THE DEPARTMENT OF POWER IN THE MINISTRY OF ENERGY (SHRIMATI SUSHILA, ROHATGI); (a) The UK Government have evinced interest in financing the extension stage of the Rihand Super Thermal Power Project.

(b) The first unit of the Rihand Super Thermal Power Project Stage-I (2x500 MW), which-was originally to be commissioned in June, 1987, is scheduled to be commissioned in the fourth quarter of 1987. The commissioning programme has been affected by delays on the part of the lead contractor in mobilising project management resources and by delays in completion of design and engineering work, supplies etc.

## USSR offer for construction of Power Plants
