

**Power project at BPCL, Bombay**

62. SHRI NARESH C. PUGLIA: Will the Minister of ENERGY be pleased to state:

(a) whether it is a fact that the Bharat Heavy Electricals Limited has secured a Rs. 33 crores contract for a Gas-turbine based power project for the Mahul refinery of Bharat Petroleum Corporation Limited at Bombay;

(b) what is the estimated generating capacity of this power project; and

(c) what are the details of this project and the time by when the project is expected to be completed?

THE MINISTER OF STATE IN THE DEPARTMENT OF POWER IN THE MINISTRY OF ENERGY (SHRIMATI SUSHILA ROHATGI): (a) to (c) M/s Bharat Heavy Electricals Limited have been awarded contract for the 2x15 MW Captive Power Plant being installed by Bharat Petroleum Corporation Limited at their refinery in Bombay. The project, estimated to cost Rs. 43.613 crores, is scheduled to be completed by May, 1988.

with the Indian Oil Corporation for setting up  
the Karnal refinery; if so, what are the details

(b) whether Soviet Assistance is  
proposed to be utilised for it and if so, to what  
extent; and

(c) what are the reasons for not  
setting up the refinery wholly in the  
public sector?

THE MINISTER OF STATE OF THE  
MINISTRY OF PETROLEUM AND  
NATURAL GAS AND MINISTER OF  
STATE IN THE MINISTRY OF FINANCE  
(SHRI BRAHM DUTT): (a) Government have  
decided that the Karnal refinery be set up in  
the joint sector. M/s Indian Oil Corporation  
will be the public sector promoter and they  
have been asked to finalise a memorandum of  
understanding with M/s Tata Chemicals Ltd.  
as the co-promoter. The two parties will take  
26 per cent of the equity each and the rest will  
be raised from the public. The refinery is  
expected to be set up in 60 months.

(b) Possibilities of Soviet Assistance will  
be explored for the branch pipeline which  
will supply crude oil

to the refinery as well as for other facilities of the refinery, to the extent possible.

(c) Constraint of resources did not permit the setting up of this refinery in the public sector.

#### **Use of foreign trade mark**

65. SHRI B. SATYANARAYAN REDDY; Will the Minister of INDUSTRY be pleased to state;

(a) what steps Government have taken to ensure that no foreign trade marks are Used for goods to be sold in India; and

(b) how will the Government of India ensure that trade marks like Chesterfield and Rothmans, which are being used in India, without the Government's action will not take place in the future?

(a) While approving foreign collaboration agreements, a condition is laid down that the use of foreign brand names will not be allowed On products meant for internal sales.

(b) The issue of regulating the use of foreign trade marks on internal sales is engaging the attention of the Government.
