- (d) Alignment- on the north, side;... of the existing National Highway of Bongaon was approve earlier However recently -the -State- Government has sent two alternatives one on the south side and the other following the existing route. These proposal including a suitable site for the new bridge over river lehha-mati are under correspondence wiih-the State Government
