SHRI RAJESH PILOT: There are two ways of removing these problems. One is to deal with this problem at the stage of manufacture i.e. the root cause. We have written to the Ministry of Industry and we have given them suggestions that at the manufacturing stage itself measures should be taken by which this problem is solved. This one is already existing. Then under the Motor Vehicles Act we will put restrictions and we are putting in other types of restrictions and some research is also being carried out by the Central Institute of Road Transport to see how this pollution can be reduced. We are sending these suggestions to the State Government. We are very much concerned about It and the Government is taking whatever strictest measures can be taken in this direction.

SHRI G. SWAMINATHAN: Implementation of whatever laws are there is all right. But in other countries they are not allowing either buses or lorries or private cars on the roads after a certain period of life-span. We find that in India some of the lorries, buses and other kinds of vehicles are so old that they are emitting huge quantity of smoke. And especially in Delhi buses are so old that most of the smoke is coming out of these buses. Will the Government try to have a sort of time limitation for these buses and lorries trucks?

SHRI RAJESH PILOT: Sir, this is one of the suggestions which we sent all over the country. We sent suggestions to the State Governments and transport operators. This is one of the suggestions that has that we must limit the age of the vehicle. And, it is a fact that when the vehicle becomes old it more smoke and more problem for the environment. Now, I am coming with my suggestions before the House and whatever the House approves, we will make the provision in the Act.

AN HON. MEMBER: Is it applicable to Members of Parliament also?

THE MINISTER OF STATE INTHE DEPARTMENT OF EDUCATION AND CULTURE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (SHRIMATI KRISHNA SAHI): (a) No, Sir.

SHRI V. RAMANATHAN: May 1 know how many Bal Bhawans are run in India with Central assistance and in which cities are they located and what is the criteria under which financial assistance is provided to these institutions?

श्रीमती कृष्णा साही : सभापति महोदय, भारत मरकार की कोई योजना ऐसी नहीं चलती है । भारत सरकार केवल वाल भवन सोशायटी, नई दिल्ली को विनीय सहायता देती है । प्रान्तों में कोई ऐसी योजना नहीं चलाती है । स्राप्ता दूसरा प्रकृत क्या था, मैंने मुना नहीं?

SHRI V., RAMANATHAN: What is the criteria under which Central assistance is provided?

SHRI NIRMAL CHATTERJEE: What is their number in different States?

श्रीमती कृष्णा साही: सभापति महोदय भैंदेने कहा कि भारत सम्दकार राज्यों में कोई ऐसी योजना नहीं चलाती है। बाल भवन सोसायटी जो दिल्ली में बही परियोजना भारत सरकार की दूसरी कोई परियोजना नहीं है। इसलिये स्टेट्म को देने का कोई प्रश्न नहीं उठवा, बाल भवन सोमायटी जो है वह कुछ राज्यों में वित्तीय सहायता देती है। बाल भवन चलाने के लिये दिल्ली में जो बाल भवन सोसायटी है वही कुछ राज्यों को सहायता देती है, भारत सरकार कहीं कोई सहायता नहीं देती । अगर धाप उन राज्यों का नाम जानना चाहते हैं तो मैं उनके नाम बना सकती हं जहां वाल भवन...

MR. CHAIRMAN: No, they don't want. Second supplementary now.

SHRI V. RAMANATHAN: What are the difficulties in giving financial assistance to these institutions?

MR. CHAIRMAN: You did not understand the answer The answer is, the Centre does not give any assistance; it is the State Government which gives assistance.

SHRI P. V. NARASIMHA RAO: There is a Bal Bhawan Society of India. Central Government gives aseistance only to the Bal Bhawan Society of India which, in turn, depending on the projects undertaken by the State Bal Bhawans, gives some assistance to them. The amount which we are giving to Bal Bhawan Society of India is admittedly not as much as we would wish it to be; but that is again a part of the financial constraint. This is the pattern.

श्री राम चन्द्र विकल : उपप्रभापित महोदय, मैं यह जातना चाहंगा कि बाल भवत सोनाइटी के पदाधिकाणी कौन हैं श्रीर इसका उद्देश्य क्या है। ग्रगर केन्द्र में ग्राप इसकी सहायता करते हैं तो राज्य सा कारें भी ग्रगर ऐसी सोमाइटियां बनाय तो क्या उनको भी श्राप सहायता दे पायेंगे या नहीं दे पायेंगे?

श्रीमती कुरूण शाही: सभापित मही-दय, दिल्ली में जो भारत सरकार की परि-योजना है उसको तो श्रीमती मिथिला झा चला रही हैं श्रीर राज्यों में ऐसी सोसाइटियां चलाने के लिये श्रभी भारत सरकार के पास कोई योजना नहीं है।

PROF. C. LAKSHMANNA: The Minister says that there is no scheme of Government of India to run Bal Bhawans...

SHRIMATI KRISHNA SAHI: ... in the State.

PROF C. LAKSHMANNA: Obviously, you have to run in the States only. The question is, if the Bal Bhawans are being run there already, what is the type of relationship which Government of India maintains so that the objectives for which these Bal Bhawans are established are fulfilled?

श्रीमती कृष्णा साही : सभागति मही-दय, हमारे मंजी जी ने भी कहा है गौर मैंने भी कहा है कि बाल भवन जो दिल्ली में है वही कुछ प्रान्तों में कुछ वित्तीय महा-यता देना है बाल भवन जलाने के लिये। हम लागं इसके लिये कुछ नहीं देते हैं, इसलियं हमारा रिलेशनशिप इस संबंध में स्टेट्स के साथ कहां होता है ? बाल भवन सोसाइटी एक रजिस्टर्ड सोसाइटी है और रनकी जो वित्तीय योजनायें हैं उसके अनु-सार वे कुछ मदद करती हैं। यदि माननीय सदस्य जानना चाहेंगे तो में बना सकती हूं कि उनकी क्या योजनायें हैं और किस <mark>श्</mark>राधार पर वे उनको चलाते हैं। लेकिन इतना मैं फिर बताना चाहुंगी कि हम इनको नहीं चलाते हैं।

SHRI JAGESH DESAI: I would like to know from the hon. Minister whether any guidelines are given to the Bal Bhawan Society about the places where the Bal Bhawan should be established. More deserving people are slum-dwellers. I want to know whether the Government has considered this aspect and given some

guidelines s_0 that these Bal Bhawans can be established in slum-dwellers areas so that the poorest of the poor can get benefit out of it.

श्रीमती कृष्णा साही: सभापति महो-दय, बाल भवन सोसाइटी द्वारा जो कृष्ठ राज्यों में परियोजनायें चलाई जा रही हैं उसमें उन लोगों ने कुछ गाइड लाइंस टी है। इसका मृख्य उद्देश्य बच्चों के ग्रन्दर जो सृजनात्मक शक्ति है उसका विकास हो, बच्चों के व्यक्तित्व का विकास हो और उनमें स्वतंत्र अभिव्यक्ति का विकास हो। इस प्रध्ययन को चलाने के लिये नेशनल चिल्ड़न ग्रसम्बली युथ फेस्टिबल वे करते हैं, नेशनल इन्टेग्नेशन जोवल कैम्प वे करते हैं। 19 नवम्बर से 18 दिसम्बर तक उन्होंने यह चलाया है ग्रीर उसमें पर्या-वरण संबंधी बहुत सी शिक्षायें बच्चों को दी गई हैं।
