Setting up of Navodaya Schools in Tribal areas

So far, 81 Navodaya Vidyalayag have been opened in 20 States/Union Territories Under th« Navodaya Vidyalaya

Scheme, it is proposed to establish one Navodaya Vidyalaya in every district of the country during the Seventh Five Year Plan in a phased manner.

- (d) whether Government are considering any proposal for increasing allocations under different heads so that the State comes at Par with the national average in terms of roads kilometreage?
- THE MINISTER OF STATE OF THE MINISTRY OF SURFACE TRANSPORT (SHRI RAJESH PILOT); (a) A_s on 31-3-1983, it is 25. 26 Kms. per 100 sq. Kms. in Madhya Pradesh against the' National average of 47. 27 Kms. per 100 sq. Kms,
- (b) to (d) The Central Government, is primarily concerned with the development of National Highways network only and "funds are being provided to the respective State Governments depending upon the requirements of States and availability of adequate resources for the 6 purpose.
- So far as State Roads network is concerned, the responsibility rests entirely on the State Governments
