100 वाट के एक ट्रांसमीटर और 2x10 वाट के एक ट्रांसमीटर की स्थापना पर वर्तमान मूल्यों पर क्रमशः 37.05 लाख रुपए पूंजीगत व्यय और 31.00 लाख रुपए अनावृत्ती व्यय होने का अनुमान है। इसमें भूमि खरीदने, भवन या स्टाफ क्वार्टरों पर होने वाला व्यय, जो स्थान-स्थान पर भिन्न होता है, शामिल नहीं है।

THE MINISTER OF STATE IN THE DEPARTMENT OF DEFENCE PRODUCTION AND SUPPLIES IN THE MINISTRY OF DEFENCE (SHRI SHIV-RAJ PATIL): (a) The "Value of production achieved by HAL in 1986-87 was Rs. 611. crores, (provisional). The value of production anticipated in 1987-88

is

Rs. 652 crores. The, percentage increase works out to 6.7.

(b) Government is considering the induction of kn Advanced Jet Trainer into the I. A. F. and the question of its licenc production in Indi'a. It would not be in public interest to disclose further details in thfc regard.

THE MINISTER OF STATE OF THE MINISTRY OF INFORMATION AND BROADCASTING (SHRI AJIT PAN-JA): (a) No, Sir.

(b) Does not arise.

(c) The budgeted commercial gross receipts of Doordarshan for the current year i. e, 1987-88 are estimated to be. Rs. 138. 32 crores.,

(d) The rates of advertisements and sponsored programmes have been rationalized. It is expected that this will help Doordarshan to 'achieve the required target.

settled between the Boeing Company and Pakistan.

**Negotiations for Purchase of Super Computer From Russia**

692. SHRI K. VASUDEVA PANICKER: Will the PRIME MINISTER be pleased to state the per capita central plan assistance, State-wise, in the annual plan for, 1986-87 and 1987-88?

(a) whether it is a fact that Government are negotiating with the Russian Government for purchase of super computer;'

(b) if so, by when the said deal is likely to be finalised; and

(c) what is the amount involved in the deal?;

THE MINISTER OF STATE IN THE MINISTRY OF SCIENCE AND TECHNOLOGY AND THE MINISTER OF STATE IN THE DEPARTMENTS OF OCEAN DEVELOPMENT, ATOMIC ENERGY, ELECTRONICS AND SPACE (SHRI K. R. NARAYANAN): (a) There are no specific negotiations with the Russian Government for the purchase of super computer at present. However, the Elbrus\*, super computer has been included in the protocol signed by the Indo-Soviet, Working Group on Computers in March 1986.

(b) and (e) Do not arise.

Loan assistance provided by LIC to Rural Water Project in Maharashtra

(a) what is the amount of loan assistance provided by the Life Insurance Corporation of India to Maharashtra Government against an estimated expenditure of 175 crores for rural drinking water supply and

(b) whether Government propose to direct the LIC to increase the loan assistance.

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI JANARDHAN POOJARI): (a) and (b) Loans for rural water supply schemes are given by the LIC on the basis of amounts intimated to them by the respective State Governments out of the allocations made by the Planning Commission and after examining the viability of the schemes sent by them. During 86-87, the State Government of Maharashtra intimated to L. I. C. their requirement of an amount of Rs. 7.9 crores for rural water supply schemes and the same has been sanctioned by L. I. C.
