World Bank loan to Oil India Limited

136, SHRI D. B. CHANDRE GOWDA: Will the PRIME MINISTER be pleased, to state-

(a) whether the World Bank has recently extended a loan worth \$ 140 million to the Oil India Limited for new exploration work and also for new schemes to improve production;

(b) if so, what are the terms and conditions of the loan extended by the World Bank;

(c) the manner in which the Oil India Limited propose to invest the loan; and

(d) the extent to which the production of the oil in the country is likely to be boosted and the extent of imports to be minimised?

THE MINISTER OF STATE IN THE MINISTRY OF PETROLEUM AND NATURAL GAS AM: THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI BRAHM DUTT): (a) The International Bank for Reconstruction and Development (World Bank) has recently approved a Loan of \$140 million to India for Oil India Limited Petroleum Project. However, the Loan agreements are, yet to be signed.

(b). The Loan would be for 20 years, including 5 year grace period with a variable interest, currently 7.92 per cent, linked to the cost of World Bank bor-

rowings. It also carries, an annual commitment charges of 0.75 per cent on undisbursed balance. These are standard BRD terms,

(c) The project comprises (i) application of production improvement schemes such as infill drilling, pressure maintenance, workover of wells including hydraulic fracturing and application of enhanced oil recovery techniques in some of the partially depleted oil fields in Assam; (ii) implementation of gas reinjection scheme and association gas supply network in a few oil fields in Assam; (iii) exploration involving acquisition and interpretation of high resolution seismic data and drilling of exploratory wells; and (iv) institution building to strengthen OIL's technical capabilities, data acquisition and processing, drilling, as well as through training and the purchase of equipment for research and development.

(d) The production improvement schemes are expected to yield incremental oil, production of 20 million tonnes over 20 years. In addition, the exploration activities under the project are also expected to yield benefits which cannot be quantified at this early stage.

Expansion programme of television in Karnataka

THE MINISTER OF STATE OF THE MINISTRY OF INFORMATION AND BROADCASTING (SHRI AJIT PANJA): (a) Yes, Sir.

(b) The permanent T. V. Studio Centre at Bangalore and a 100 W T. V. transmitter at Chickmaghir with a service range of about 25 kins, are expected to be commissioned during 1987-88.

Central Vigilance Commission Report on increase in Bank frauds

*138. SHRI HARVENDRA SINGH HANSPAL: Will the PRIME MINISTER be pleased to state:

(a) whether it is a fact that the Central Vigilance Commission in its report for 1985, has described that the - increase in the number of bank frauds, malpractices and lavish expenditure on buildings is causing huge loss to the exchequer;

(b) if so, what steps Government have taken on the report of the Central Vigilance Commission;

(c) whether there is any proposal to review the working of the banks to bring down the 'cases of frauds, malpractices and other lavish expenditure; and

(d) if so, what are the details there_

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI J AN-., ARDHAN POOJARI): (a) to (d) Whilst the Annual Report on the Central Vigilance Commission for 1985 ' does not- specifically state that increase in. bank frauds malpractices etc. is causing huge loss to the public exchequer, it provides an analysis of the types and forms of misconducts.. and malpractices, *the modus operandi* and, the operational reasons which provide

scope for corruption, as have come to the notice of the Commission from the cases received by it from the Banking sector during 1983; 1984 and 1985. The analysis is important for its preventive value. Banks jhave taken steps to strengthen" their vigilance machinery, tone up "and strengthen control and supervision, strengthen management information system, follow-up and inspection/audit arrangements and draw up time-bound programmes ' of clearing arrears in balancing of books and reconciliation of inter_bararich and' other accounts. Bank also review periodically the incidence of frauds, malpractices etc. and take appropriate preventive and punitive measures. These are also reviewed ffrom time to time by RBI and deficiencies in sys_ terns and procedures are brought to the notice of the banks indicating the safeguards which should be adopted.
