THE MINISTER OF STATE IN THE DEPARTMENT OF INDUSTRIAL DEVELOPMENT IN THE MINISTRY OF INDUSTRY (SHRI M. ARUNA-CHALAM): (a) and (b) Appreciation in the value of the Japanese Yen has adversely affected several segments of the Indian Industry. Automobile units having collaboration with Japanese companies lhave been particularly affected because it has led to a substantial increase in the cost of their imports.

(c) The appreciation of Japanese Yen has not directly affected iron ore exports from India to Japan as the export price has been fixed in US dollars. However, due to the fall in its crude steel production, Japan has. cut down iron ore imports.

(d) To cope. with the problem, the automobile manufacturers have been advised and' encouraged to accelerate indige-nisation of components so as to reduce dependence on imports. Some fiscal concessions have'  $als_0$  been extended to the automobile industry;
